

PRIVACY POLICY AND CONSENT DECLARATION

The British Army is part of the United Kingdom's Ministry of Defence. This privacy policy and consent declaration explains how we use the personal data you provide in completing this form (Application Form for British Army RI26).

The British Army's Data Controller is the United Kingdom's Secretary of State for Defence (Ministry of Defence, Whitehall, London, SW1A 2HB).

The British Gurkhas Nepal (BGN) Data Protection Officer is the Regimental Administrative Officer (HQ BGN, Man Bhawan, Jawalakhel, Kathmandu).

Purpose and legal basis of the processing

The purpose for processing the data provided by you in completing this form is in general to administer your application to join the British Army, And specifically to:

- Confirm your physical attributes meet recruiting requirements as per JSP 950 and PAP 17
- Comply with religious sensitivities
- Meet the requirements of the 1947 Tripartite Agreement
- Comply with the Armed forces Act 2006
- Comply with JSP 440 Manual of Security
- Comply with the Asylum and Immigration Act 1996
- Meet the requirements of Ministerial Arrangements under Sect 41.2d of the RRA 1976

The legal basis for processing this data is your explicit consent. You have the right to withdraw your consent at any time.

Recipients of the personal data

Your personal data will be protected and handled by specific BGN personnel to process your application. It will not be transferred to other organisations, or overseas.

The data on this form will be retained for 10 years and then destroyed. If your application to join the British Army is successful, you will be asked to provide similar personal information again once you arrive in the United Kingdom, which will be subject to a different legal basis that will be made clear at the time.

Your rights with respect to your personal data

As the data subject, you have the following rights:

- The right to obtain from the Data Controller, or the Data Protection Officer, confirmation as to whether or not personal data about you is being processed.
- The right to request a copy of your personal data. More than one copy may result in a fee to cover administrative costs.
- The right to request information about the purposes of the processing.
- The right to request information about the recipients or categories of recipient to whom the personal data have been or will be disclosed.
- The right to request information about the envisaged period for which the personal data will be stored.
- The right to request rectification or erasure of personal data or the restriction of processing of personal data or to object to such processing..
- The right to lodge a complaint with a supervisory authority.

Consequences of failing to provide the personal data

The consequences of not providing the data required by this form will result in you not being able to attend Recruit Selection.

By signing the declaration below you are providing confirmation that you understand the information provided above and give explicit consent to the processing of the personal data on this form for the purposes of administering your application to join the British Army. Further, you agree that any photographic images taken during the selection process by BG staff are owned by the British Army and you consent to their publication.
